

ORDINANCE NO. 2012-03

COUNTY OF ST. CLAIR, MICHIGAN

AN ORDINANCE OF THE CITY OF ALGONAC, ST. CLAIR COUNTY, MICHIGAN TO AMEND CHAPTER 8, ARTICLE II "FIRE PREVENTION CODE" BY ADOPTING IN SECTION 21 THE INTERNATIONAL FIRE CODE IN PLACE OF THE BOCA NATIONAL FIRE PREVENTION CODE AND REPEALING SECTION 23.

THE CITY OF ALGONAC ORDAINS:

SECTION 1. AMENDMENT

Chapter 8, Article II is hereby amended by adopting Section 8-21 to read as follows:

Sec. 8-21. Adoption of International Fire Code, Current Edition

A certain document, three (3) copies of which are on file in the office of the City Clerk, being marked and designated as "The International Fire Code, Current Edition," as published by the International Code Council (ICC) is hereby adopted as the fire prevention code for the City for the control of buildings and structures as herein provided; and each and all of the regulations, provisions, penalties, conditions, and terms of "The International Fire Code, Current Edition," are hereby referred to, adopted, and made a part hereof as if fully set forth in this Article with the additions, insertions, deletions, and changes, if any, as prescribed in Section 22.

Sec. 8-23. Repealed.

SECTION 2. SEVERABILITY

This ordinance and each of the various parts, sections, subsections, sentences, phrases, and clauses hereof are declared to be severable. If any part, section, subsection, sentence, phrase, or clause is determined to be invalid or unenforceable by a court of competent jurisdiction, it is hereby provided that the remainder of the Ordinance

shall not be affected thereby and shall remain in full force and effect.

SECTION 3. REPEAL.

Any and all Ordinances of the City of Algonac or any parts or provisions thereof, to the extent that they are contrary to or inconsistent with the provisions of the within Ordinance, are hereby expressly repealed.

SECTION 4. RATIFICATION

All other provisions of the Code of Ordinances of the City of Algonac, Michigan except as herein modified or amended are hereby expressly ratified and affirmed.

SECTION 5. PUBLICATION.

This Ordinance shall be published in accordance with the terms, provisions, and requirements of the City Charter of the City of Algonac, Michigan, and in accordance with and to the extent required by the statutes of the State of Michigan.

SECTION 6. EFFECTIVE DATE.

This Ordinance shall take immediate effect upon publication in accordance with the provisions and requirements of the City Charter of the City of Algonac.
